AN EMERGENCY ORDINANCE

Authorizing the Director of Public Works to enter into an amendment to the waste collection packer vehicle rental agreement, Contract No. MA 1505-ECD 2020-4, with Rush Truck Leasing, Inc. dba Rush Refuse Systems to extend the term for an additional four months.

WHEREAS, under Ordinance No. 194-2020, passed by the Cleveland City Council March 2, 2020, the City, through the Director of Public Works, entered into City Contract No. MA 1505-ECD 2020-4 with Rush Truck Leasing, Inc. dba Rush Refuse Systems for the rental of up to 9 (nine) waste collection packers for a period of up to 9 (nine) months expiring September 30, 2020; and

WHEREAS, the Department of Public Works has contracted for the purchase of 5 (five) new waste collection packers needed to restore its fleet to the operating capability required to meet City waste collection service obligations, but which, due to the long manufacturing lead time for such vehicles, will not all be delivered until February 2021; and

WHEREAS, Rush Refuse Systems has agreed by its August 19, 2020 Quote, to extend the term of the rental agreement, City Contract No. MA 1505-ECD 2020-4, for 5 (five) packers for an additional 4 (four) months expiring January 31, 2021 upon the same terms and conditions; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That, notwithstanding any provision of the Codified Ordinances of Cleveland, Ohio, 1976, the Director of Public Works is authorized to enter into an amendment to Contract No. MA 1505-ECD 2020-4 with Rush Truck Leasing Inc. dba Rush Refuse Systems, for the rental of waste collection packers to extend its term for an additional 4 (four) consecutive months for up to 5 (five) packers. All other terms of the rental agreement shall remain the unchanged and in full force and effect.

<u>Section 2.</u> That the amendment shall be prepared by the Director of Law.

Section 3. That the cost of the rental agreement extension shall not exceed \$106,500 and shall be paid from Fund No. 11 SF 006, RQS 7013, RL 2020-81.

<u>Section 3.</u> That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
