### Ord. No. 794-2020

By Council Members Cleveland and Kelley (by departmental request)

Authorizing the Director of Port Control to employ one or more appraisers or one or more firms of appraisers to provide professional services necessary to appraise real and/or personal property, rights of way and/or easements and other interests in real property, on an as-needed basis, for a period of one year with three one-year options to renew, the second of which requires additional legislative authority.

Estimated Cost: \$84,000
