Res. No. 780-2020

By Council Members B. Jones, Cleveland, McCormack, Brancatelli and Kelley (by departmental request) Approving the continuation of the Cleveland Superior Arts Improvement District as a Special Improvement District in the City; accepting petitions from owners of property in the District; approving a new plan for public services; declaring it necessary to provide safety, cleaning, and other services for the District; and providing for the assessment of the cost of such work upon benefited property in the District; and declaring an emergency. Ord. No. 795-2020

By Council Members McCormack, Cleveland, Brancatelli and Kelley (by departmental request)

Authorizing the Director of Port Control to employ one or more professional consultants to maintain, manage, secure, and promote City-owned properties at the North Coast Harbor and to fulfill the Common Area Maintenance Agreement with the stakeholders of North Coast Harbor, for a period of one year, with three one-year options to renew, exercisable by the Director of Port Control.

Estimated Cost: \$400,000

Ord. No. 847-2020

By Council Members Brancatelli and Kelley (by departmental request)

Authorizing the Director of Economic Development to enter into a grant agreement with Cleveland 2030 District, or its designee, to provide economic development assistance to partially finance administration of the Cleveland 2030 District Program.

Estimated Cost: \$50,000
