AN EMERGENCY ORDINANCE

Authorizing the Director of Finance, on behalf of Cleveland Municipal Court, to enter into an amendment to Contract No. PS 2020-137 with Oriana House, Inc. to provide additional services for appropriate placement for defendants to be assigned into supervised pretrial release without the sanction of incarceration under the Community Corrections and Supervised Pretrial Release Programs.

WHEREAS, under Ordinance No. 458-2020, passed June 3, 2020, this Council authorized Contract No. PS 2020-137 with Oriana House, Inc. to provide for appropriate placement for defendants to be assigned into supervised pretrial release without the sanction of incarceration under the Community Corrections and Supervised Pretrial Release Programs; and

WHEREAS, additional services are necessary; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Finance, on behalf of Cleveland Municipal Court, is authorized to enter into an amendment to Contract No. PS 2020-137 with Oriana House, Inc. to provide additional services for appropriate placement for defendants to be assigned into supervised pretrial release without the sanction of incarceration under the Community Corrections and Supervised Pretrial Release Programs. All other terms and conditions contained in the contract shall remain the same.

<u>Section 2.</u> That the amendment shall be prepared by the Director of Law.

Section 3. That the costs of the contract amendment shall not exceed \$600,000 and shall be paid from Fund No. 01-0115-6320, RQS 0115, RL 2020-46.

<u>Section 4.</u> That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
