Request for Legislation

To authorize the Director of the Department of Public Utilities to enter into one or more requirement contracts for the purchase of labor and materials necessary to clean high voltage insulators, bushings, lightning arrestors, transformers and associated equipment at various locations for a period of two (2) years for the division of Cleveland Public Power.

Background/Purpose:

Labor and materials needed to clean insulators, bushings, lightning arrestors, transformers and associated equipment in substations, and transmission and distribution overhead lines.

Scope of Work/Commodities/Services:

Labor, material and equipment to clean pin cap insulators, suspension insulators, circuit breaker bushings, pothead bushings, lightning arrestors, and any other insulators and bushings for energized 138,000 volt, 69,000 volt, 13800 volt, 12000 volt and 2400 volt equipment and pole lines for the Division of Cleveland Public Power.

Justification/Urgency:

This contract will set into place the process to expedite the maintenance and cleaning of insulators, bushings and lightning arrestors on energized equipment. Without cleaning road salt and other contaminants off this equipment, electricity will arc and track over and onto these components for the transmission and distribution systems causing large scale system outages.

Anticipated Costs and funding source:

The estimated cost of the two year contract is \$425,000.00. The funding source is CPP's operating budget.

Schedule or Term of Contract:

This legislation will lead to one or more requirements contracts for a term of two years.
