AN EMERGENCY ORDINANCE

Authorizing the Director Aging to enter into an amendment to Contract No. PS 2019-070 with Community Housing Solutions to develop, operate, and implement the Age Friendly Home Investment Program.

WHEREAS, under Ordinance No. 675-18, passed June 4, 2018, as amended by Ordinance No. 1215-2019, passed December 2, 2019, this Council authorized the Director of Aging to enter into Contract No. PS 2019-070, with Community Housing Solutions ("CHS") to develop, operate, and implement the Age Friendly Home Investment Program which provides home repairs to seniors; and

WHEREAS, an amendment to the contract is necessary to provide that the compensation to CHS shall not exceed certain dollar limits in the first and second option years so that additional funding is available now for needed repairs for seniors; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Aging is authorized to enter into an amendment to Contract No. PS 2019-070 with CHS to develop, operate, and implement the Age Friendly Home Investment Program to provide that the compensation to CHS shall not exceed \$1,775,000 in the first option year and shall not exceed \$2,125,000 in the second option year. All other terms and conditions contained in the contract shall remain the same.

<u>Section 2.</u> That the amendment shall be prepared by the Director of Law.

<u>Section 3.</u> That the costs of the contract amendment shall be paid from funds approved by the Director of Finance.

Section 4. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
