WHEREAS, under Ordinance No. 342-2020, passed March 23, 2020, this Council

International Brotherhood of Electrical Workers, Local 39; and

WHEREAS, an addendum to the Agreement is necessary to add the formerly non-union

title of Chief Electric Transmission Operator as a recognized union title in the International

Brotherhood of Electrical Workers, Local 39; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual

daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That under division (B) of Section 4117.10 of the Revised Code, this

Council approves an addendum to the 2019-2022 collective bargaining agreement with

International Longshoremen Association, Local 1317, under the terms contained in File No.

74-2021-A.
