AN EMERGENCY ORDINANCE

To supplement the Codified Ordinances of Cleveland, Ohio, 1976, by amending Section 135.071, as amended by Ordinance No. 1188-12, passed September 7, 2012 related to maximum age for original appointment to the Divisions of Police and Fire.

WHEREAS, this ordinance constitutes an emergency measure providing for the immediate preservation of public peace, property, health, or safety, now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Codified Ordinances of Cleveland, Ohio, 1976, are supplemented by amending Section 135.071, as amended by Ordinance No. 1188-12, passed September 7, 2012, to read as follows:

Section 135.071 Maximum Age for Original Appointment to the Divisions of Police and Fire

- (a) No person is eligible to receive an original appointment to the Division of Police as a Police Trainee on or after the person's fortieth birthday.
- (b) No person is eligible to receive an original appointment to the academy for the Division of Fire on or after the person's fortieth forty-first birthday.
- Section 2. That Section 135.071, as amended by Ordinance No. 1188-12, passed September 7, 2012, is hereby repealed.
- <u>Section 3.</u> That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
