## **AN EMERGENCY RESOLUTION**

Supporting West Creek Conservancy's Clean Ohio Fund Greenspace Conservation Program application for the Zaclon River Landing Project in the City of Cleveland.

WHEREAS, the State of Ohio, through the Ohio Public Works Commission, administers financial assistance for the preservation of open spaces, sensitive ecological areas and stream corridors, through the Clean Ohio Fund Greenspace Conservation Program; and

WHEREAS, the Zaclon River Landing Project will provide an opportunity to perpetually protect an approximately 3-acre parcel on the east side of the Cuyahoga River, with the intent to restore, enhance and create an equitable access point on the Cuyahoga River Water Trail; and

WHEREAS, the project is a small yet important deliverable of the recently adopted Vision for the Valley; and

WHEREAS, this Council recognizes the importance of this project and respectfully requests that the Ohio Public Works Commission gives favorable consideration to West Creek Conservancy's application; and

WHEREAS, this resolution constitutes an emergency measure for the immediate preservation of public peace, property, health or safety, now, therefore,

## BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLEVELAND:

<u>Section 1.</u> That this Council supports West Creek Conservancy's Clean Ohio Fund Greenspace Conservation Program application for the Zaclon River Landing Project in the City of Cleveland.

<u>Section 2.</u> That the Clerk of Council is hereby directed to transmit a certified copy of this resolution to West Creek Conservancy, Derek Schafer, P.O. Box 347113, Parma, Ohio 44134.

<u>Section 3.</u> That this resolution is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
