AN EMERGENCY ORDINANCE

Authorizing the Director of Public Utilities to exercise the second option to renew Contract No. CT 2002 PS 2020-48 with CHN Housing Partners to provide administration and other related services related to the City's Discount Water Affordability Program.

WHEREAS, under the authority of Ordinance No. 1275-2019, passed November 18, 2019, the Director of Public Utilities entered into Contract No. CT 2002 PS 2020-48 with CHN Housing Partners to provide administration and other related services related to the City's Discount Water Affordability Program; and

WHEREAS, Ordinance No. 1275-2019 requires further legislation before exercising the second option to renew on this contract; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Public Utilities is authorized to exercise the second option to renew Contract No. CT 2002 PS 2020-48 with CHN Housing Partners to provide administration and other related services related to the City's Discount Water Affordability Program, at a cost not to exceed \$200,000. This ordinance constitutes the additional legislative authority required by Ordinance No. 1275-2019 to exercise this option. (RQS 2002, RL 2021-77)

Section 2. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
